

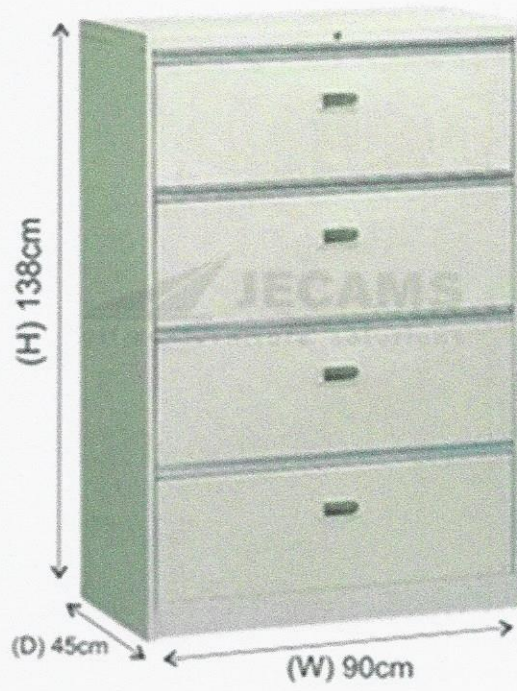
STEEL LATERAL CABINET (3 LAYER)
