RE: INELIGIBILITY OF TPB TO GRANT FY 2013
PERFORMANCE BASED BONUS (PBB) AND
PERFORMANCE BASED INCENTIVE (PBI)

Dear Secretary Jimenez and COO Enerio,

Please be advised that the Tourism Promotions Board (TPB) has failed to fully meet the conditions and requirements to qualify for the grant of PBB to its Officers and Employees for FY 2013 under GCG MEMORANDUM CIRCULAR (MC) No. 2013-05 (RE-ISSUED) and the Checklist of Documents to be submitted by GOCCs to Qualify for the FY 2013 Performance-Based Bonus (PBB). This is based on the:

- Failure of TPB to achieve a weighted-average score of at least 90% on its 2013 Performance Scorecard (see Annex A);
- Review by the GCG of the completeness of required submissions from TPB for PBB FY 2013, including compliance with Good Governance Conditions specific to the GOCC Sector;
- 3. Validations received from the Civil Service Commission (CSC), PhilGEPS, the Department of Budget and Management (DBM), and the A.O. No. 25 Inter-Agency Task Force (IATF) Secretariat, pursuant to the directive by the IATF.

Based on the foregoing, the GCG hereby declares TPB <u>INELIGIBLE</u> to grant the PBB to its Officers and Employees. Consequently, pursuant to GCG M.C. No. 2013-06 (Re-Issued), failure to qualify for PBB means that the Appointive Members of the Governing Board of TPB shall also not be qualified to receive the Performance-Based Incentive (PBI).

Based on the UNWTO Tourism Highlights, 2014 Edition, in 2012 out of 48 countries in Asia and the Pacific, the Philippines ranked 14 th in terms of international tourist arrivals This is in contrast to the baseline figure provided by TPB which is 17 th out of 43 countries. Due to the misrepresentation in the baseline, the 2013 target is not reflective of the intentio of the Commission during the negotiation, which is to move the country's rank by two spots up. However, considering that there was an improvement in the ranking of the Philippines, the rating of 5% for this indicator is accepted. For 2014, revise the target to Move two spots up from last year's spot (11 th place)
