#### 21 November 2024

#### I. BACKGROUND

The Wild Bird Club of the Philippines will be organizing the 13th Asian Bird Fair on 20-24 November 2024 at The Tent, Las Piñas City which will be attended by 100 local and 100 foreign delegates from 17 different countries: Mongolia, China, Japan, Korea, Malaysia, Singapore, Indonesia, Thailand, Cambodia, Nepal, Bhutan, India, Sri Lanka, Australia, Colombia, Peru, and Taiwan.

The 13th Asian Bird Fair will highlight the different bird fairs/festivals in Asia and promotes birdwatching as an ecotourism activity. It will also highlight the ecotourism potential, as well as the cultural aspect of the host city/destination.

The Wild Bird Club of the Philippines has requested the Tourism Promotions Board (TPB) for a hosted themed dinner with cultural show on 21 November 2024 at their official dinner venue.

In return, Wild Bord Club expressed the prominent placement of the TPB logo on all their event marketing collaterals including banners, posters, jerseys and social media platforms, live acknowledgement of TPB's contribution during their programs, inclusion of TPB logo on event related communication materials and press releases, time allotment for TPB's representative to present the PMT Program and airing of TPB-PMT's official Philippine National Anthem video during their respective programs.

By supporting these events, TPB aims to promote more exhibitions and adventure tourism in the Philippines.
